- Any information submitted via contact forms, newsletter forms, or strategy access forms


Automatically collected data

4. How We Use Your Personal Data

2. Essential service providers

They only process data on our behalf and cannot use it for their own purposes.

We do not share data with any other third parties unless required by law.

Data retrieved from CTM

Renouveau may request data from CTM related to your account status for service coordination (e.g., account opened/not opened, onboarding progress).

We do not receive or store sensitive financial or identification documents.

6. International Data Transfers

When sharing data with CTM Global Investment Ltd (Mauritius), we ensure protection through:

- contractual safeguards,
- secure transfer mechanisms,
- CTM's regulatory obligations under the FSC Mauritius.

All other data is stored and processed within the EU/EEA.

7. How Long We Store Data

We store personal data only as long as necessary for:

- legal obligations.

Examples:

- Mailing list data: until you unsubscribe
- Client-related data: up to 5 years (to comply with financial regulations)

When data is no longer required, we securely delete it.
